## **YMCA North Learning Extension Center Code of Conduct**

1. When you arrive at the YMCA, you must sign in check in with program staff. An information form and signed code of conduct must be on file for you to attend.
2. When you arrive at the YMCA you must agree to a temperature check and wearing a mask throughout program hours.
3. The LEC begins at 8:00am and ends at 3:00pm. All program participants are expected to sign out or have arrangements for transportation by 2:45pm. If this is a problem, please speak with the staff.
4. While you are in the YMCA LEC, you will act respectfully toward the other program participants as well as all YMCA staff and members.
5. You are responsible for your own belongings and personal property while at the YMCA. You will also show respect to others' belongings and personal property, as well as the YMCA's property and grounds. The YMCA is not responsible for lost or stolen property; it is recommended you do not bring valuables into the facility, or place them in a locker when you are here. All property brought into the YMCA is subject to being searched by YMCA staff to ensure the safety of all participants.
6. Inappropriate behavior will not be tolerated and may result in consequences up to suspension. This includes, but is not limited to, use of tobacco, consumption of alcohol, drug use, fighting, verbal put-downs, threats, public affection, obscenities or obscene gestures.
7. You are expected to exhibit the YMCA core values of caring, honesty, respect, and responsibility at all times.
